Head Start - a free preschool program for children ages 3 to 5 years until eligible for kindergarten. It is funded through the Administration for Children and Families (ACF), Office of Head Start and the Maine Department of Health and Human Services. Grantees are expected to raise 20% of the cost of the program through local contributions of cash or in-kind goods and services. The federal program targets children living at or below the federal poverty rate but allows enrollment of children from other income levels under strict guidelines. At least 10% of children enrolled must have a diagnosed disability.
